## **Miss Teen Logan County Fair Rules & Regulations:**

1. Contestant must be between the ages of 13-15. Contestant must have reached her 13th birthday and cannot have reached her 16th birthday by October 31, 2022. She must be single, never married, never had a marriage annulled, never had a baby or be presently with child. Contestant must be a natural born female.
2. You will model one Casual Attire outfit and one Formal Evening Gown.
3. The winner will be acclaimed and reign as "Miss Teen Logan County Fair" representing Logan County at the state pageant. She will compete for the title of "Miss Teen Kentucky County Fair" held in Louisville during the Fall board meeting of the association in October 2022.
4. Should the winner fail to represent the Logan County Fair in the state pageant, or becomes ineligible before the state pageant, the title will be given to the alternate and she represent Logan County at the state pageant.
5. Miss Teen Logan County is open to local and non-residents of Logan County, KY.
7. All contestants will be required to pay or have their entry fee sponsored, which must accompany the entry form. Entries will be accepted until June 10<sup>th</sup> at 4:00pm at the Logan County Chamber of Commerce or the Logan County Extension Office.
8. Only one adult is allowed backstage with contestants.
9. Out of town judges will be present and their decisions are final. Do NOT approach the judges at any time.
10. Mail in the entry fee and make money order payable to: Logan County Fair.
